Pursuant to a vote of the Members of the Woodington Homeowner's Association, Inc. on February 22, 2019, the following Amendment to the By-laws is hereby accepted and incorporated into the By-Laws of Woodington Homeowners Association Inc., recorded in Book 2555 at Page 2788 in the Office of the Register of Deeds of Greenville County:

ARTICLE V - BOARD OF DIRECTORS, SELECTION, AND TERM OF OFFICE

Section 1- Number: The association shall be governed by a Board of Directors, having a minimum of three (3) Directors and a maximum of five (5) Directors, each of whom shall serve until his or her successor is elected and shall qualify as provided in these By-Laws. No more than one (1) representative of any single distinct membership may serve as a director of the Association at one time.

Section 2- Selection and Term of Office: Annually, the membership shall elect a minimum of three (3) and a maximum of five (5) directors from the membership for the term of one (1) year... (Remainder of Article V remains unchanged and unamended)

ARTICLE VI - NOMINATION AND ELECTION OF DIRECTORS

Section 1 - Nomination: Nomination for the election to the Board of Directors shall be made by the current Board of Directors. At least thirty (30) days prior to the annual meeting, the current Board of Directors will request volunteers to fill expected vacancies on the Board. If applicable, a notice will be sent to the membership advising them of open positions and asking for volunteers to fill the positions. An election slate for members of

the Board of Directors will be prepared to include incumbent members who are seeking re-election and new candidates.... (Remainder of Section 1 remains unchanged and unamended)

Section 2 - Election: Election to the Board shall be by secret written ballot. At such election, the Members or their proxies may cast one vote for each seat on the Board, with the maximum number of votes being five (5). A ballot containing more than five votes shall be null and void. The three (3) persons receiving the largest number of votes shall In the event the person with the 4th highest number of votes receives a majority vote from those Members or their proxies casting ballots, that persona shall be elected to the In the event the person with the 5th highest number of votes receives a majority vote from the Member or their proxies casting ballots, that person shall be elected to the Board. Cumulative voting is not permitted.
